1.0 The reason for the decision

- 1.1 To receive nominations and appoint to the Council's Committees, Tribunals and Panels for 2021-22 and to confirm terms of reference, in line with the provisions of the Local Government and Housing Act 1989 and The Local Government (Committees and Political Groups) Regulations 1990.
- 1.2 Following five local by-elections for Allerdale Borough Council on 6 May 2021, this report sets out the consequent change to the allocation of seats on Committees and Panels for 2021-22 and the nominations from the political groups to those seats (To Follow).

2.0 Recommendations

- 2.1 That the allocation of seats and the appointment of Members to the various Committees and Panels of the Council as set out in the report be approved. Appendix A Nominations from Political Groups is 'To follow'.
- 2.2 That the Terms of Reference for Committees, Tribunals and Panels, as set out in Appendix B, be approved.

3.0 Introduction

3.1 On 6 May 2021 five Allerdale Borough Council by-elections were held for the Aspatria, Seaton and Northside, Ellen and Gilcrux, Christchurch Cockermouth and St Johns Workington Wards, which has resulted in a change to the composition of the Council.

- 3.2 It is therefore necessary for the Council to review the allocation of the seats on Council Committees and Panels so that they comply with the provisions of the Local Government and Housing Act 1989.
- 3.3 Due to the timing of the Elections and the date for the despatch of reports for the Annual Council Meeting it is not possible for the Group Leaders to consider the group allocations prior to sending this report out to Members.

 Appendix A to this report, the Groups' nominations for appointments to Committees and Panels for the year 2021-22, will follow as soon as possible.
- 3.4 Members are also requested to consider and approve the Terms of Reference for each Committee, Tribunal and Panel as detailed in Appendix B of the report.

4.0 Content

- 4.1 The Local Government and Housing Act 1989 and the Local Government (Committees and Political Groups) Regulations 1990 make provision in respect of the allocation of places on its committees to political groups represented on the Council.
- 4.2 The legislation applies to committees of the Council and certain other bodies. It does not apply to Executive or working groups set up by the Council for the purposes of briefing members or advising Executive.
- 4.3 Where the legislation applies, it requires that places on committees are, as far as reasonably practicable, allocated to political groups to give effect to the principles set out below, which apply in the following order.
 - a. Not all seats may be allocated to the same political group (i.e. there are no single group committees)
 - b. The majority of seats on a body are allocated to a political group if the group has a majority on the Council. No group has a majority of seats on Allerdale Borough Council so this principle is not applied
 - c. The number of seats on each ordinary committee allocated to a political group bears the same proportion to the total of seats on all committees as is borne by the number of members of the group to the total number of members on the Council.
 - d. Without offending rules (a) and (c), the number of seats on each body to which the rules on political proportionality apply bears the same proportion to the number of all seats on the body as is borne by the number of members of the group to the number of members of the Council.
- 4.4 Appendix A sets out the committees and sub-committees to which the above principles apply and the proposed allocations to each group. The following proportions form the basis of the approach adopted. This includes the Councils approach in allocating one seat to those members who are not affiliated to a group.

4.5 The successful candidates of the by-elections held on 6 May 2021 are as follows; Aspatria Ward, Kevin Thurlow (Independent), Seaton and Northside Ward, Colin Sharpe (Conservative), Ellen and Gilcrux Ward, Patrick Gorrill (Conservative), Christchurch Ward, Alan Kennon (Conservative) and St Johns Ward, Antony McGuckin (Labour).

5.0 Delivery Arrangements

The political make-up of the Council is now 18 Allerdale Conservatives, 17 Allerdale Independents, 13 Labour and 1 Moorclose Independent.
 Based on the political make-up, and with a total of 66 seats across committees, tribunal and panels, entitlement to seats is as follows:

- 5.2 At its annual meeting, the Council must appoint at least one Scrutiny Committee and a Standards Committee. The Council must appoint to any other committees which it considers appropriate to deal with those matters which are not reserved to Council itself or which are not functions of the executive (Executive and officer decisions).
- 5.3 There are a total of 66 seats across the Council's committees as shown:
